2. It is further informed that you and your institution is fully responsible to fulfil and maintain norms including the infrastructure both physical and human resources, teaching faculty, clinical material etc. throughout the academic year, as stipulated in regulation of National Medical Commission.

3. In case of false/wrong declaration or fabricated documents have been used for procuring permissions of MARB and any misconduct is brought to the notice of National Medical Commission or found during surprise assessment at any stage during the current academic year, your institution is liable, not to be considered for recognition of that degree. This letter of permission will be revoked for the current academic year if such exigency arises. Besides, National Medical Commission (NMC) is entitled to take all such measures against you and your college/institution as permissible under the law.

4. It is mandatory by government medical colleges to contribute 15% MBBS seats and 50% of post graduate broad specialties (MD/MS) for All India Quota respectively, to MCC of DGHS for conduction of counselling as per the directions of Hon'ble Supreme Court.

5. It is mandatory to develop a website of medical college/institution and display all the information of college and courses offered as per the guidelines issued by the National Medical Commission (NMC) from time to time.

6. If any discrepancy is found later on in respect of any data /documents, this letter of approval shall be withdrawn immediately. This LoP is further subject to the confirmation of genuineness of the Bank Guarantee submitted by the college.
